Ray Brooker called for vote.

All commission voted in favor of 89m View Lane variance.

Discussion of Section 2, B 1 of sign ordinance

Lat year P & Z recommended 10 X 12 sign, City council voted for sign 6 X 8 in. Discussion on size of sign too small. When grass grows up around it sign can not be seen.

If out on right away, just tooooo small. Sign should be on property not on right away. Spoke with realtor and the recommendation to City Council is 8 X 10 sign.

10 X 12 is actually needed to be visual.

Motion; Ray Becker; recommendation for sign is 10 X 12.

Bob McNair seconded.x

Discussion: Consider white sign with green letters and green border.

David Whatley suggested sign be raised, display higher. Realtors are responsible for trimming around sign. Use standard size same as realtors and state requirements.

David Carr spoke of some opposition; Signs need to look good, Ask realtor about size of their signs. Have all for sale signs the same size.

Ray Brooker: referred to Tampa Realtors which moved signs to window, Here in Mountains could not see. He would support a sign with all information. Same color sign in green.

Dick Parrott suggested Red and Yellow.

Bob McNair made motion: A sign 10 X 12 and a different color be adopted and should be determined by City Council.

Ray Brooker seconded-5-0

A recommendation from P & Z commission is changing 6 X 8 signs to 10 X 12. Ray Brooker amended motion 5-0

Neal Howard said get in writing for official from the City of Sky Valley.

Amendment: This sign, if 10 X 12 is legal and meets requirements of the state of Georgia

Bob McNair seconded.

Passed unanimously

Dick Parrot had questions: if my driveway on City Property can I put a sign in window. Yes, response from commission.

David Carr: thanked the commission for attending and thanked Neal Howard and David

Whatley for attending.
