Announcements

City Hall will be closed in observance of Christmas Eve and Christmas Day on Tuesday, December 24th and Wednesday, December 25th. We will also be closed in observance of the New Year on Wednesday, January 1st and Monday, January 20th in observance of MLK Day.

Garbage pick-up will be on the Tuesday after an observed Monday holiday. Thursday recycle pick-up will not be affected. If you need to dispose of garbage at any other time, the compactor is available on Knob Drive behind the postal facility to use at your convenience.

Administration

City Hall would like to take this opportunity to remind anyone renting out a residence, shall report the rental income and submit the tax due to the city. Monthly reports are due by the 20th day of the following month of collection. The hotel/motel tax form can be found on our website, www.skyvalleyga.com. If you have a month with no rentals you are still required to submit a return with a signature, stating that you collected no funds for the month. Any questions please refer to the city's ordinance that is listed on our website or give us a call. Fines can ensue with violations of ordinance.

We still have Sky Valley T-Shirts available for sale, \$20.00 each. Sizes range from Youth Small and Extra Large to Adult Small through 3XL. Adult Medium is sold out. These shirts would make wonderful Christmas presents.

The holiday lights are up and hopefully enjoyed by all. They will stay on display through the holidays and will be taken down in January.

Tax bills have been mailed and are due by Friday, January 17, 2020. If you have not received your bill, please contact Alyssa Mullins at City Hall for a duplicate billing.

The city just received notification that the 2019 Safety and Liability Grant Application through GMA, was approved and will be receiving soon, a reimbursement check in the amount of \$5,840.20.

Our website is currently in the process of being revamped and should make its debut shortly. The codification of our ordinances is also nearing completion. A notification will be sent out when these are completed.

Code Enforcer/ Building Inspector

Please check with City Hall, 706-746-2204, Monday – Friday, 8:00 a.m. until 4:00 p.m., if you need to find out if your project needs a permit. A simple phone call could answer this question and help avoid a fine for not having the proper permit. These permits are issued, and inspections are done for your safety, along with your neighbor's safety. This is a great service provided and could help you save money in the long run.

Reminder....

911 address postings must be visible at the beginning of your driveway. This is in accordance of a Rabun County Ordinance which is a must for timely response from Public Safety personnel. For clarification on where to post the 911 address or where to purchase, call City Hall.

Each publication we will list examples of items that are addressed under our City's Ordinances and/or Work that requires a permit:

Requiring a Permit:

- 1. New deck construction
- 2. Deck repairs (all)
- 3. Driveway replacement or enlarging footprint of driveway (apron & culvert required)
- 4. New doors or windows requiring structural alterations
- 5. Electrical service, upgrade, relocation or repair
